

**NAVAL PUNISHMENTS – KINGS REGULATION AND ADMIRALTY INSTRUCTIONS
BR 31/1939 and BR 31/1943**

Note. Punishments 11, 12, 13, 14, 15, 16, 17 & 18 are summary punishments that do not require warrants

- *** No 10. Cells or under canvas punishment afloat.** Low diet (bread and water) for the first three days. No bedding for the first four days, thence only on alternative days. (Without bedding the offender sleeps on a board shelf with a wood block pillow and is dressed in a canvas suit). Exercise after the first three days, one hour per day. Reading, the

- **** No 19 and 20. Birching and Caning of Boys**
- **Birching.** The punishment of birching is to be confined to boys rated as such, and to boy buglers and band boys when embarked and is to be inflicted with the birch as issued by the dockyard, and is never to exceed 24 cuts or blows; it is to be inflicted by the ships's police in the presence of the Executive Officer, a Medical Officer, two or more Petty Officers, and all the boys. The punishment is to be awarded by warrant, and in ships not carrying the Flag or Broad Pendant, the approval of the Flag Officer or Commodore is necessary.
- **Caning.** Caning on the breech, duck trousers and pants being worn, is limited to boys rated as such and boy buglers and band boys when embarked and is to be inflicted with a light and ordinary cane. The number of cuts or blows is not to exceed 12, and the punishment is not to be carried out in public. Unless he attempts to break away, the boy to be caned should not be secured but should stand and bend down to grasp a chair or firm object. Caning is intended for the serious offences of theft, immorality, drunkenness, desertion (in special cases as an act of leniency) insubordination, or gross and continued disobedience of orders. In the absence of the Captain, the Commanding Officer is not to order caning to be inflicted, unless the Captain shall be absent from duty by permission of superiord authority for more than 48 hours
